Please submit your protocol's in MS-PPT: (Please keep the following points in mind)

- The format of PPT should be in either 1997 or 2007 MS Office format. (with audio recording)
- 2. PPT should be of maximum 10 slides comprising of
  introduction, Aims and Objectives, Inclusion Exclusion criteria,
  Methodology including a flow diagram of study, Blood samples
  to be collected with volume, ethical issues and summary etc.
- 3. The time limit of presentation should NOT EXCEED 10 minutes.
